Making Health Care Decisions for Others

The living will should be used as guidance in making decisions that reflect the patient's wishes A health care proxy or surrogate is a person who can make health care decisions at any time the patient cannot decide Her decision-making authority commences when the patient loses decisional capacity and ends when the patient dies or regains

Living Amends There are some people you won't be able to make amends to, usually because of the risk of causing further harm to them or others, or of jeopardizing your financial security "Living amends" means making amends through your actions without going through a process of direct, face-to-face admission of wrongs and apology
