- Reckless Endangerment in the 1 st Degree, Penal Law Section 12025 - You are guilty of Reckless Endangerment in the First Degree when, under circumstances evincing a depraved indifference to human life, you recklessly engage in conduct which creates a grave risk of death to another person **serious bodily injury to another person. 76-5-112 Reckless ...**

76-5-112 Reckless endangerment -- Penalty (1) A person commits reckless endangerment if, under circumstances not amounting to a felony offense, the person recklessly engages in conduct that creates a substantial risk of death or serious bodily injury to another person (2) Reckless endangerment is a class A misdemeanor

Reginald T. Holbrook v. State of Maryland, No. 88 ...

Reckless endangerment is purely a statutory crime Modeled after §2112 of the Model Penal Code (“Recklessly Endangering Another Person”) and first enacted in Maryland by chapter 469 of the Acts of 1989, reckless endangerment was codified originally as Md Code (1957, 1992 Repl
